The financial results have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015, as amended) (Ind AS) prescribed under Section 133 of the Companies Act, 2013 and other recognised accounting policies to the extent applicable. The statutory auditors have conducted review of these financial results of the Company for the quarter ended and period ended September 30, 2025 in accordance with Regulation 33 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015.
- 3. The Board of Directors ('Board') of the Company at their meeting held on May 7, 2025 had approved the closure of operations of the Garment Division ('Undertaking') and subsequent disposal of the related assets and liabilities of the Undertaking. Consequently, the assets of the Undertaking that are to be sold/transferred has been reclassified as "Assets held for sale" on closure of Garments Division during the period ended September 30, 2025. Further, the net results of the Undertaking for the current period and previous period(s) has been disclosed separately as discontinued operations as required by Indian Accounting Standards (Ind AS) -105 Assets held for sale and discontinued operations and Schedule III of the Companies Act, 2013.

- 5. A exceptional loss of ₹ 545.79 lakhs has been recognised on the remeasurement of assets classified as held for sale, determined at the lower of their carrying amount and fair value less cost to sell due to closure of Garments Undertaking. This loss has been separately disclosed under 'Exceptional Items' in the above financial results.
- 6. The Company has opted for the concessional tax regime under section 115BAA of the Income-tax Act, 1961, as introduced by the Taxation Laws (Amendment) Act, 2019. Accordingly, the Company has computed its tax expense and deferred tax for the quarter and half year ended September 30, 2025 as per the provisions of this section. Consequently, the effective tax rate is lower compared to the previous regime, and deferred tax assets/liabilities have been re-measured based on the revised rates. Further, the current tax effect on income/(loss) of discontinued operations has been considered in current tax on continuing operations for the quarter and period ended September 30, 2025.
